The United States Probation Office for the District of South Carolina seeks <u>fixed-price</u>, <u>itemized</u> quotes from Hilton Head, SC, hotels to host a training conference for three days (Wednesday through Friday). Preferred dates are November 3-5, 2021.

Check in Date: Thursday, November 4, 2021; 5 attendees

Check out Date: Friday, November 5, 2021

Please notify us immediately if you cannot accommodate.

Please exclude tax. An ST-8 tax exemption certificate will be provided upon request.

All conference costs will be billed to a master account to be paid after the event. No deposit will be paid.

Quotes must be emailed to <u>yvonne_rojas@scp.uscourts.gov</u> by **5:00 PM Thursday, October 21, 2021**. Please include the completed Provision B-5 under terms and conditions (attached).

Neither this request nor the response(s) it generates guarantees a contract.

An award, if issued, will be based on the lowest-priced, technically acceptable offer and will be contingent upon available funding as of October 7, 2021.

Notice of an award will be given by 5:00 PM Thursday, October 28, 2021.

Costs to Quote:

- Lodging
 - Current locality per diem rate for Hilton Head, SC, is \$115.00. The CONUS per diem rate is \$96.00/night. Do not be discouraged from submitting a quote, however, if you are unable to honor the either the locality or CONUS per diem rate.
 - A rooming list will be completed by the U.S. Probation Office which will contain each guests name, arrival/departure time and any special needs.
 - Rooms shall be available for check-in after 3:00 p.m. If rooms are not available when guests arrive, the hotel shall store their luggage. The hotel shall also store luggage for any guest requiring delayed departure.

- The hotel shall invoice the U.S. Probation Office for the room rate only. Individuals are responsible for payment of incidental charges upon departure unless otherwise specified.
- Some guests may wish to extend their stay to the days leading up to or following the conference at the same rate offered for the conference. This is at the hotel's discretion.
- Itemize any additional fees that will <u>not</u> be waived (parking, safe/warranty, destination, etc.)
- Minimum food/beverage expense, if any
 - Please also provide a catering menu with prices. No outside vendors.
