## **REQUEST FOR QUOTATION**

The United States Probation Office for the District of South Carolina is conducting a solicitation for full-service commercial packing and moving services of our Headquarters Office.

## STATEMENT OF WORK

The Statement of Work (SOW) for this Request for Quotation (RFQ) includes all labor, supervision, transportation, equipment, materials and tools necessary for the complete and satisfactory performance to facilitate the requirements listed below.

The U.S. Probation Headquarters Office located at 1845 Assembly Street, 1st Floor, Columbia, SC, is approximately 4,800 square feet. This office consists of a lobby, kitchen, conference room, breakroom, workroom, large file room and seven offices.

The Contractor will pack all items located in/on desks, furniture, and cabinets into moving boxes.

The Contractor will be responsible for moving all boxes and furniture to their designated location. Some items will be moved to the adjacent buildings, and the remainder will be moved to a storage facility.

The Contractor will be responsible for protecting all furniture, furnishings, and appliances during the relocation.

#### GENERAL CONDITIONS

Vendor acknowledges and agrees to the following conditions when submitting their bid:

- Packing and moving services shall be completed during business hours (exclusive of federal holidays) Monday Friday between 8:30 am 4:30 pm.
- U.S. Probation Office Staff will be onsite during the packing and relocation process.
- All services are to be completed to the satisfaction of the U.S. Probation Office.
- Contractor will be responsible for any damage to government property.
- Contractor will be responsible for protecting adjacent work areas and finished surfaces from damage.

## BASIS OF AWARD

Offers are evaluated based on price. Award may be made to the lowest-priced offer for quote which meets the technical requirements outlined in this RFQ. This RFQ does not commit the government to pay any costs incurred in the preparation of the submission of your offer or to contract for supplies or service should

none of the vendors meet the necessary specifications. The awarded vendor will be required to register with sam.gov or complete and submit Form AO213 within three days after notice of intent to award and prior to the issuance of a purchase order.

#### **SECURITY**

All employees working on this relocation must have a valid ID and pass inspection by security. All employees will be escorted by U.S. Probation Staff at all times during the packing and moving process.

## INSURANCE CERTIFICATE

The contracting officer will require the General Contractors and any of its subcontractors who perform any work during the relocation to obtain and maintain insurance policies for liability and damage. A copy of these policies must be provided to the U.S. Probation Office prior to the start of service.

## **TAXES**

The U.S. Probation Office is a tax-exempt organization. A copy of our tax exemption certificate can be provided upon request.

## **INVOICES**

Invoices will be accepted after completion of moving services. All invoices will be processed under Net 30 terms unless otherwise specified.
